

# LATE LOTTERY & GAMING CREDIT CLAIM FORM

This form is being used by a taxpayer to:

**Remove** a credit from a **Real Estate or Personal Property** Tax Bill. No credit should have appeared on the tax bill according to the taxpayer.

AND

A copy of this form, and **a copy of your tax bill** must be submitted prior to **October 1**, to the Wisconsin Department of Revenue, PO Box 8971, Madison, WI 53708-8971. Phone #(608)266-9457 or (608)266-0772.

A refund check will then be issued by the State of Wisconsin.
